PARTICIPATION RULES

1. The entrant (driver name & company) waives and releases all rights and claims for any injuries, losses, damages, and liabilities of any kind, including, but not limited to, bodily injury, death, and property damage, arising out of or related to the entrant's participation in or attendance at the Kenworth of Cleveland Truck Show. This includes Hissong Group, Inc., Kenworth of Cleveland, and their respective officers, directors, employees, agents, contractors, licensees, patrons, and guests.
2. Hissong Group, Inc., and Kenworth of Cleveland shall be held harmless from and against all liability, responsibilities, losses, damages, costs, or expenses of any kind whatsoever (including, but not limited to, costs, interest, and attorney's fees).
3. Entrant grants Hissong Group, Inc., and Kenworth of Cleveland the right to photograph and use images of my truck, including any individuals present, for marketing and promotional purposes. I understand that if a minor is present in the photograph, their identity will be protected by obscuring their image, or the photograph will not be used. I release all claims to compensation for the use of these photographs.
4. By signing this agreement, the entrant releases Kenworth of Cleveland and Hissong Group from any and all liability for injuries or theft that may occur to the entrant or the entrant's employees' property from any cause whatsoever, prior to, during, or after the period covered by this agreement.
5. Entrants must ensure their equipment is protected so that no injury or damage will result to the public, visitors, guests, employees, or any person or property within the competition area, and entrants will be liable for any such damage.
6. Entrants are responsible for leaving their area free of all materials after the show. Entrants will be billed for any goods and materials left behind, or for the cleaning and/or repair of their space.
7. Proof of insurance must be provided upon request.
8. A current DOT long form must be available upon request.
9. Trucks will be judged and awards presented on the day of the show.
10. There will be no in/out privileges during show hours.
11. Truck owner(s) must be present to accept their award.
12. **NO ALCOHOL OR DRUGS** – No alcoholic beverages or illegal drugs are permitted on the premises. Any person(s) found to possess alcohol or illegal drugs during the show will be disqualified from consideration for a show award and asked to leave the premises immediately.
13. If any provision of this Agreement is held to be invalid or unenforceable, in whole or in part, by a court of competent jurisdiction in the State of Ohio, the remaining provisions shall remain in full force and effect. The invalid or unenforceable provision shall be reformed and construed to effectuate the intent of the parties to the extent permissible under Ohio law. If such provision cannot be reformed or construed in a manner that is valid and enforceable, it shall be severed from this Agreement, and the remaining provisions shall be enforced to the fullest extent permitted by law.
